Anguilla is not a member of the Paris Convention, but the provisions of the Convention have been implemented in its national law. Consequently, Convention priority may be claimed and priority claims are enforceable locally.

Categories of Trade Marks  
There are provisions for the registration of COLLECTIVE, SERIES and SERVICE MARKS.

There are no provisions for the registration of DEFENSIVE MARKS.

Classification  
The International Classification of goods and services applies.

A single application may cover any number of classes of goods and/or services.
